O'FARRELL'S TRIAL.

(From the South Australia Register.) The witnesses for the prosecution merely recapitulated the evidence given at the preliminary inquiry.

At half-past 13 Mr. Martin replied on behalf of the Crown, denying that any insanity had been proved.

The Judge, in summing up, addressed the jury to consider the evidence, and to give their verdict.

The jury retired, and returned to Court, after one hour, with a verdict of guilty.

O'Farrell, when asked if he had anything to say why sentence should not be pronounced, replied in a firm tone, "No, Sir, nothing."

His Honor then passed sentence of death in the usual form, and the prisoner was removed.

THE INSURRECTION IN CALTE. A dispatch to the London Standard, dated the 29th inst., contains the following intelligence:

These engagements have taken place within the last three weeks—Gazette in the province of Galicia, at Lita in Oporto, and at Santos. The fight on the 1st inst. (Gazette) was a severe one on both sides.

At about an hour before sunrise yesterday—Friday—morning our Settlement was startled by the advent of a hurricane, whose like has not been experienced among us since the institution of the Colony.

Although we had been visited by a thunder-storm on the morning of the day previous, which is generally supposed to have a cooling effect upon the atmosphere.

About 2 o'clock on the morning of Friday the people were aroused by the discharge of lightning and thunder, which seemed to come from every point in the heavens.

Fences were overthrown for miles; and such of our largest trees as were not uprooted and overthrown, were lashed to and fro like reeds in an ordinary gale.

In the British House of Commons on the 11th inst., Mr. Corry explained the heavy estimates of considerable length.

It is understood that Prince Alfred will come as far as Sicily in his own frigate, the Galatee, and after crossing the Isthmus by rail he will go on board a royal yacht which will be in waiting at Alexandria to receive him.
